## Top 10 Tips for BRAND NEW PARALEGALS



Even though I've only been blogging since October 2008, I hoard ideas for posts like a magpie hoards food and shiny items. Come to think of it, I also hoard food and shiny items...

But in regard to blog posts which might interest other paralegals, I'm starting to look like a bag lady, with several large piles of legal articles, magazines, pamphlets, newspaper

clippings and written notes. And let's not talk about all the quick emails I send myself with ideas, which is where I found a January 2009 email reminding myself to talk about how to be successful on that first paralegal job.

#### Here's my "Top 10 List for Brand New Paralegals":

- 1. **Listen more than you talk.** Pay close attention many things become clear through keen observation.
- 2. After listening carefully, **ask thoughtful questions** and get clear instructions. If the people you need to question arenot easily accessible, try well-drafted email inquiries.
- 3. Save samples or go-by documents in a notebook and/or word processing directory. If you've worked with a document once, know where to find it the next time you need it.
- 4. **Carefully review existing firm documents** and immediately learn how to thoroughly search the firm's word processing directory. Search it before asking co-workers for help.

- 5. Always have a pad available to **take excellent notes.** If someone is giving you instructions, make sure that you are writing them down legibly and accurately.
- 6. Use the firm's calendaring/to do system to **enter deadlines and reminders for all tasks.** If the firm doesn't have a system, create one that works for you.
- 7. **Prioritize your daily tasks.** Don't be afraid to ask for guidance if you are not sure what to do first.
- 8. **Obtain a basic CLE education** in your specialty area(s) by attending courses for beginners (paralegals and attorneys), reviewing CLE manuals available in the firm's library and reading recommended publications.
- 9. Seek mentors by joining at least one active paralegal association, reviewing paralegal listservs (even once a week via digest is better than not at all), personally networking with other legal professionals at CLE seminars, and virtually networking with other legal professionals on LinkedIn, Twitter and Facebook.
- 10. **Stay up-to-date in your field** by reviewing relevant magazines, ezines and websites, and by following reputable legal bloggers.

The legal field is always changing, and the most talented legal professionals are always learning. A successful paralegal is alert, curious and, like a magpie, is a seeker and hoarder of shiny new information.

## OVERVIEW OF CHANGES IN LAWS FOR 2009

#### Patricia F. Clapper, ACP, NCCP

Our legislature was hard at work last session enacting new laws and changing old ones. In addition to the ban on texting while driving and the ban on smoking in bars and restaurants, here are a few notable changes over the last half of 2009:

• An attorney who drafts a will or codicil must now have his or her name and business address affixed to the instrument and indicate that he or she is the drafter.

• The spousal allowance for estates has been increased from \$10,000.00 to \$20,000.00.

• Estates valued at less than \$20,000.00 can be probated as small estates. This is an increase from \$10,000.00.

• Deeds must now include the address of the Grantor AND Grantee, state whether the property being conveyed was the primary residence of the Grantor, and state that the excise taxes were paid and how much was paid. This change was made so appraisers can better track the sale prices of homes.

• Changes were made to the NC Limited Liability Company Act.

• A license plate frame on your car can no longer cover the state's name, or the year and month stickers.

• Several AOC forms have been updated, including the subpoena form. It's a good idea, at least once a year, to update your forms database by checking www.nccourts. org and see if forms your firm uses have been updated. The updated dates are in the bottom left hand corner.

## **Mortgage-RESPA Changes**

Home Affordable Mortgage Refinance offered by Fannie Mae (FNMA).

If you are familiar with the application process you know that when application is made, the lending institution, whether a Bank, a Mortgage Company outside a Bank or a Broker, they have three (3) business days to give you three (3) primary disclosures. These included:

- 1. Good Faith Estimate (GFE)
- 2. Truth-in-Lending Disclosure (TIL)
- 3. Servicing Disclosure

RESPA is changing as of January 2010 the following:

- The initial GFE become the binding GFE -the fees entered on this form are becoming more binding then they have previously been. There are certain tolerances but those are only rare instances and minimal % adjustments.
- All fees typically charged to borrowers regardless of who pays must be listed on the GFE.
- Fees disclosed, but paid by others are still bound by tolerances.
- Each numbered block explains the fees on the GFE and you will be able to ask questions about all fees to determine why a fee is what it is.
- The first block will contain all charges to you from the lender, broker, processing fee, underwriting fee etc.
- The second block will contain any Discount Fee. You may have a credit or charge for the interest rate you have chosen and it will be included in block one. You may receive a credit of a certain amount for higher interest rate, which will reduce your settlement charges (or) you may have to pay a charge to get a lower interest rate which will increase your settlement charges. This second block is about your interest rate only and the fees will be included, if any in the first block.

This is a brief explanation of the fees charged specifically by the lender. The other fees, most of them are charges you will pay for settlement charges which are incurred from the closing agent, the title company for title insurance, attorney fees, recording fees, transfer taxes, accrued interest and any fee that is designated as a part of closing. Please note that is report is not conclusive but it is relating to important mortgage information that you need to know.

The main purpose of this article is for you to know that once you receive the initial GFE, your fees will not be significantly different on the HUD1 at closing, than they are on the initial GFE. Previously this was part of some serious problems by getting to the closing table without sufficient funds to close or the closing cost being much more than initially stated. Especially on the Broker side. As you know the Broker does not close your loan in their name, they must close through an approved lender and now the approved lender will be responsible for all fees from the Broker as well and there will be State and Federal guidelines to follow and some State limits are different than others previously and this may be changing. There are many other areas of news about what has happened in our mortgage meltdown process and should be of interest to all who want to stay abreast of important decision made upon our behalf.

Please note that this is something in your favor. A lot has happened in the Mortgage World and it seems like it is taking forever to recover. The States Regulators and Federal Regulations dictate certain charges you pay. The individual Bank or Broker has no control over the fees that are set at maximums but they should maintain integrity and moderation per their code of ethics to be reasonable with the entire process.

## **Identity Theft: Protect Yourself**

#### **GET FREE SECURITY FREEZES**

A security freeze stops credit reporting agencies from releasing any information about you to new creditors without your approval, which can stop identity thieves from getting new credit in Your name.

- All North Carolinians can get free security freezes online. For more details, visit www.ncdoj.gov
- Identity theft victims and seniors can also freeze their credit for free by mail or phone.
- Provide your full name, past home addresses, SSN, birth date, and two proofs of residence.
- To get a security freeze by mail or phone, contact the three major credit bureaus

#### **GET FREE YEARLY CREDIT REPORTS**

- You are entitled to one free credit report from each of the three nationwide credit bureaus every year. To get your free reports, go to www.freecreditreport.com or call 1-877-322-8228.
- To monitor your credit year round, ask for a free report from a different credit bureau every four months.

#### PROTECT YOUR SOCIAL SECURITY NUMBER

- Don't carry your Social Security card in your wallet.
- Give your Social Security Number (SSN) only when absolutely necessary.
- Ask why a SSN is needed, who will have access to it, and how it will be kept confidential.
- Don't print your SSN or driver's license number on your checks.

#### DESTROY DOCUMENTS YOU DON'T NEED

- Shred "pre-approved" credit card applications, old bank statements, insurance forms, etc.
- Learn about shred-a-thons in your area. Email alerts@ncdoj.gov and provide your county for updates or check the calendar at www.ncdoi.gov.

#### **MONITOR FINANCES**

- Limit the number of credit cards you carry.
- Copy credit cards (front and back) and keep them in a safe place in case a card is lost or stolen.
- Watch billing cycles for missing bills and review monthly statements carefully. Contact creditors if you miss a bill or if there are charges you don't recognize.
- Use automatic deposit for payroll, social security, or other federal benefit checks. Sign up for automatic deposit of federal checks by calling Gov Direct at 1-800-333-1795.
- Review your Social Security Earnings and Benefits Statement for errors in your yearly salary. To order a statement, call 1-800-772-1213.

#### **Protect Your Information Online** SURFING AND SHOPPING

- Keep spyware and virus protection software up-to-date, and install a firewall.
- Secure your wireless router and use the built-in encryption mechanism.
- Only provide your SSN or financial account numbers online through a valid, secure website. Secure websites often have an icon in the shape of a lock in the lower right-hand corner. A secure website's address will change from http to https.
- Pay for online purchases by credit card when possible. Federal law limits your liability to \$50 maximum if your credit card number is lost or stolen. Paying by credit card can also give you a better chance of getting your money back if your order never arrives.
- When ordering goods online, ask about refund policies, print order confirmations and keep track of delivery dates. It is best to order from trusted businesses or businesses that you confirm are legitimate.
- When selling items online, watch out for real-looking fake checks and money orders. Be wary of overpayments and endorsed checks. Never agree to wire excess payments back to the buyer or to someone else.
- Read privacy policies and inquire how your personal information will be used.
- Use one low-limit credit card for all online purchases or request a one-time-use number from your credit card company each time you want to make a purchase online.

#### **EMAIL**

- Beware of emails that ask you to confirm your personal information or account number, or that ask you to transfer money, even if the email appears to come from a bank, Internet Service Provider, business, or charity. Forward the email to spam@uce.gov.
- Never send your SSN or financial account numbers by email unless using encryption software.
- Be careful when clicking on links provided inside an email, even from a trusted source.
- Emails that say you've won the lottery, promise you can make a lot of money, or plead for help transferring money are almost always scams.

#### **PASSWORDS**

- Avoid PINs or passwords such as your mother's maiden name, family members' birth dates, your SSN or phone number, or a series of consecutive numbers (i.e., 1, 2, 3, 4).
- · Combinations of letters, numbers, and special characters make the strongest passwords.
- Don't carry your PINs in your wallet or purse.
- Don't share PINs or passwords, even with close friends or relatives.
- Choose a different PIN for each account.

#### Watcb Over Your Mail

- Stop pre-approved credit card offers by calling 1-888-5-OPT-OUT or visiting www.optoutprescreen.com.
- Place outgoing mail into a locked mailbox such as a blue postal service box.
- Don't leave incoming mail sitting in an unlocked mailbox.
- Cut down on unwanted mail by contacting the Direct Marketing Association at www.dmachoice.org.

#### Beware of Scams and Frauds

- Never give personal information to telemarketers who call you on the phone.
- Sign up for the national Do Not Call registry at 1-888-382-1222 or www.donotcall.gov to cut down on unwanted calls from telemarketers.
- Ask for and check references for door-to-door sales, home repair offers and other products.
- Verify that charities, businesses and others who contact you are who they claim to be before you provide any personal information. If you think the request for information is legitimate, hang up and contact the company at a number you know is valid to verify the request.
- Sign up for alerts about new scams at alerts@ncdoj.gov or by visiting wvm.ncdoi.gov

## **NCPA Student Scholarship Winners**

#### Debby Sawyer, ACP-Student/School Relations Chair

Each year, NCPA offers a Student Scholarship to any paralegal student enrolled in an accredited North Carolina paralegal educational program. The scholarship is determined by an essay competition, with the essay topic of "I have chosen to be a paralegal..."

All winners receive a complementary student registration to the Annual Meeting and Seminar, a complementary one-year student membership to NCPA, and a scholarship check to be paid to his or her school. First place winners receive \$400.00; Second place winners receive \$300.00; Third place winners receive \$200.00; and Fourth place winners receive \$100.00.

This year I am excited to report that we received a total of 37 essays from 15 different paralegal programs statewide. I'm sure it was a difficult decision for the judges. Below are the names of the Scholarship Recipients, along with their winning essays:

#### Natalie Copeland, 1st Place Winner Meredith College

My desire to be a paralegal is not rooted in a childhood fantasy created by a John Grisham novel-turned-movie or from a legal television drama, in which stories about good and evil are played out against the backdrop of a courtroom. I have never seen myself as a heroic paralegal, like the one Julia Roberts portrays in the film Erin Brockovich. Instead, I have chosen to be a paralegal because the paralegal profession will enable me to pursue a career filled with the best, most meaningful work.

In college, I was a member of Alpha Phi Omega (APO), a co-ed service fraternity that supported local charities through community service activities and fundraising initiatives. As an APO member, I assisted local organizations in their efforts to solve some of today's most pressing problems, such as, healthcare and education. While my volunteer work did bring some concrete improvements to my community, I quickly realized that it would take more than my volunteer efforts to bring about permanent change in society. I have always remembered the cold winter night that I volunteered at the hospital and I overheard a young mother crying on the phone to her child's father. The young couple's 4-year-old son had leukemia and the hospital bills had consumed so much of their income that they did not have enough money to pay their electric bill. I was struck by how unfair it was that even though the young mother and I were close in age, and lived within a few miles within a few miles of each other, our lives were worlds apart. I knew then that I could not single-handedly tackle all of the inequalities in American society, but that night I promised myself that whatever career I chose, I would work to level the playing field as much as I could.

Evil lawyer jokes aside, the law is perhaps the most powerful mechanism for both large and small-scale social improvements, and that is the real reason why I have chosen to enter the legal field. As much as I love volunteering, I know that my volunteer efforts alone will not make healthcare more affordable for young mothers or provide the educational opportunities needed to make future generations competitive in a global economy. While community service does have the potential to improve human life, it is the law which influences permanent societal change and equalizes the condition of man. Therefore, I want to make my life in the law because the law does have the capacity to bring long term improvement to human life and it is noble in that respect.

I am not sure where I will be in ten years. Maybe I'll work for law firm, or, maybe I'll be involved in government, helping to make public policy decisions. The possibilities are endless, and I do not have a master plan. I do know that working in the legal field as a paralegal is a natural choice for me. Regardless of the path that I choose, I will remember the promise I made to myself a few years ago, and I'll fall asleep each night knowing that someone out there is better off because of the work I did that day.

#### Sabrina Eckels, 2nd Place Winner Cape Fear Community College

Choosing to be a paralegal is not something that just happened overnight. I have had experiences and given thoughtful consideration as to what I would like to contribute to the legal profession since a young age. The earliest incident that I can remember was in second grade when Mr. Warner, one of my arts teachers at Sunset Park Elementary set up mock trials in the auditorium. I had never seen anything like it, and I was pining for more. I secretly hoped we would be doing mock trials for our activity of the day, every day.

I immediately took a liking to the concept of the judicial process. Throughout the remainder of my education, I exercised every opportunity to sit in the court room in New Hanover County. I tremendously enjoyed taking field trips to the courthouse to observe the process whenever I had the opportunity to, whether it was civil or criminal. I got a certain feeling in my stomach-it felt like my first trip to the mountains or my first time on a scary rollercoaster. My other classmates were too busy talking to notice what was going on in our midst. We were experiencing the American Justice System! By sitting and observing what goes on in the courtrooms, I knew from that point on that I had to be involved with the justice system in some capacity.

My mother was a translator for the courts, and for a few attorneys in town. She freelanced for one criminal defense attorney in particular, and from her connection, I was offered a part time position at the firm when I was 17 years old. My interview consisted of the attorney and me going to the New Hanover County jail and sitting in a cell with a man that had been charged with trafficking cocaine. I had to translate what the attorney was saying to the defendant, and the defendant's reply back to the attorney. For the next four years, my job would be a fast-paced, hands-on experience with the clients, the court rooms, clerks, and other attorneys.

My supervising attorney became my mentor, and I became very familiar with what a criminal attorney does. I also helped the family law attorney with interviewing clients and taking the initial phone calls and setting up consultations. My altruistic character comes out when people need help, especially in the legal field. I have a caring attitude with clients, and I develop their trust, and I would be the only secretary that clients wanted to talk to. Being a volunteer in different organizations through out the years makes me understanding and I have developed the skill of being a good listener. I took on a lot of responsibility at the law firm while I was attending classes at night to finish my associate's degree.

When I graduated with my associate's degree, I decided that before I transferred to a four year university, I would take classes to become a certified paralegal. Even though I have 4 cumulative years of experience in being a legal secretary, I still wanted to know more

about the procedure and substantive portion of the law. I wanted to get below the surface of my work. Being in the program for one semester has helped me tremendously. I am studying law that I never would have been exposed to, or even considered working for a firm that practiced these areas of law. I am becoming even more interested in the paralegal profession. I am beginning to understand the very important role of the paralegal and the roles of the attorneys more every day.

I have chosen to be a paralegal to help others, whether it is a client or the general public. Being an assistant to even one attorney is no simple task. You have to have tough skin, not be afraid to speak your mind, be able to multi task, be friendly, and be deadline driven, meanwhile not losing your head. I have been working since a very young age and I know that I am all of that and more. I'm going in knowing that this is right for me and I am excellent at what I do, and I wouldn't mind doing it forever. I know that I already have the experience, but having an education to back my experience is in my greatest interest. Some people burst under high pressure but I thrive in that type of environment. I can't wait to start my career as a paralegal!

#### Alaina K. Thum, 3rd Place Winner Forsyth Technical Community College

I have chosen to become a paralegal because I want to be engaged in an interesting career that will use my personal skills of observation, organization, tenacity and interpersonal communication. I understand that there are many careers from which I could have chosen. In fact, during my senior year of high school, I took advantage of a job shadowing program in which I shadowed a nurse, a physician, a teacher, a physical therapist, and a computer analyst. It was my experience at the courthouse, however, in the office of one of the assistant district attorneys that convinced me that being a paralegal was the right career for me.

My career goal is to be litigation paralegal. This aspect of law is both interesting and challenging. It is also an area that offers the paralegal a great opportunity to be involved in the process from start to finish. Whether in a large law firm or small, the paralegal is always an important team member is the field of litigation.

However, each journey begins with a single step. In my case, it was a TV Show. The name of the program was Law and Order and I was fascinated by the subject material of each case. The storylines were well written, the characters well played, but it was the complex and diverse legal issues that remained with me long after the one hour show ended. I wanted to know more about the subject matter involved. I wanted to see if there were other cases similar to the fictional one I had just seen. I didn't realize it then but I was taking my first steps toward the paralegal profession and I was doing something I loved, which was research.

When I began taking my first classes as a paralegal, I discovered that my favorite ones involved research such as title searching for Real Property or finding cases and statutes in Legal Research and Writing. I even enjoyed briefing cases for Case Analysis and Reasoning. Those issues that had fascinated me on Law and Order played out before my very eyes as we researched Supreme Court cases dealing with First Amendment rights and NC court cases on medical malpractice. The whole research process reminded me of geometry class in high school where we would link a set of proofs together to form a solid foundation for a well known rule we used in our everyday calculations. Without knowing where that authority came from, we could not understand the principles behind the equation. Title searching was like treasure hunting as we went behind the neighborhood of our property and measured out the distance between landmarks on a map while keeping track of which portions belonged to which heirs and any foreclosures that took place due to bankruptcy. The stories behind each case or each property were so much more interesting than any you could find on a television show, once again proving that real life is stranger than fiction.

Nevertheless, despite my love for the research part of paralegal work, I have also discovered another important aspect of the paralegal profession. The cases and the stories are wonderful but it is the people that matter most. I have been involved in a number of church activities where we have fed the homeless, visited those in prison, or repaired someone's house for Operation In As Much. Seeing the need of so many people up close while coming to understand their situation personally, I am thankful I have found a profession where I can be of great assistance to so many more. As a paralegal, I will be the first one that the clients meet when they come in. I will be their contact when they call the law office with questions and I relay the answers from my lawyer to them personally over the phone or at the office. There are also so many opportunities for volunteer work as a paralegal that I am sure I can continue to give back to the community that has helped me obtain a first rate education while helping those with the greatest need at the same time. As a paralegal, I desire to serve wherever I am needed and I look forward to the opportunity provided by this profession.

I have chosen to be a paralegal not because of the money I can make nor the prestige I could gain. The truth is simple. I love the work. I love the research, the writing, and the people. I have learned so much from my classes and my teachers. My next hope is to learn even more from the lawyers I will work for, the paralegals I will befriend, and the clients I will serve. Henry Ford once said, "Coming together is a beginning. Keeping together is progress. Working together is success." My paralegal education is the beginning, getting a job is progress, but becoming an indispensable team player in a law firm would be true success.
